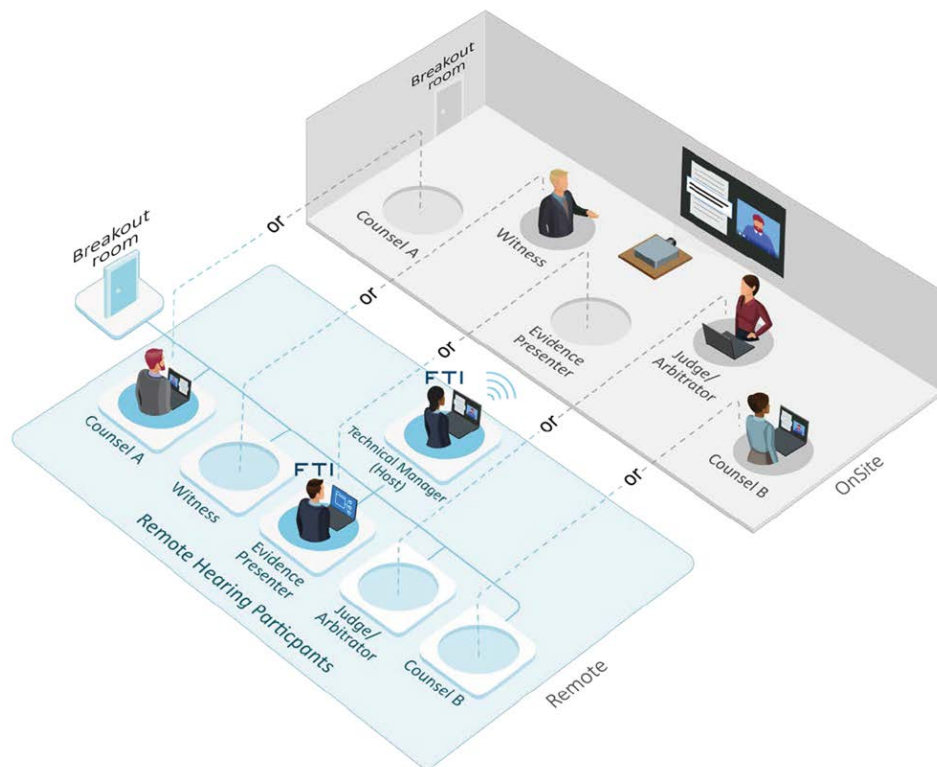
- Unlike some others, neither our consultants nor the platform impose an outside naming convention on the evidence.

### Onsite, Remote or Hybrid Hearings

Arbitral hearings are far more varied than they were in years past and FTI Consulting is expert at supporting any mix of onsite and remote participants.
